ANNUAL TERMITE INSPECTION: We will be having our annual termite inspection done by Economy Pest Control in sections on 3 separate dates. Please see the map attached to the Green Sheet Email to know which day your unit will be inspected. Section 1&2 (yellow) will be done on: Tuesday July 12th 8:00am – 12:00pm. Sections 3, 4, and 5 (pink) will be done on Wednesday July 13th 8:00am – 12:00pm. Sections 6&7 (blue) will be done on Thursday July 14th 8:00am to 12:00pm. If you cannot be home for the date/time that you are scheduled for, please call Economy at (812) 330-9100 to schedule an alternate date/time. You can also email Economy at economytermitesandpest@gmail.com. If you have a garage, please leave your garage door open during your inspection date/time. If you do not have a garage, please call/email Economy to schedule your inspection. For any questions or concerns about the termite inspection, please contact Economy.

JULY UPDATES: June has been a very hot and dry month, with total rainfall amounts of 1.18 inches. This is 3 inches below normal (average June rainfall 4.46 inches), making this our 8th driest June on record. Sherwood Green's lawn care contract calls for weekly mowing. After discussing the current weather conditions with Brad Fleener (our dedicated lawn care contractor), your HOA President feels it is best to defer mowing until next week. We are expecting rain this weekend, and we hope it relieves our parched conditions. The Fleener team is expecting to resume mowing after July 4th. Tree trimming will take place this summer. We will be removing dead tree limbs, cutting back branches that are encroaching on homes, cutting down dead trees in danger of falling, etc. More information on that will be made available as soon as we have dates that the crew will be out to work on them. Mole treatment will begin on the small amount of mole hills over the next 2 months. With the weather improving, we'd like to remind folks that pea gravel area maintenance, plantings, and weeding are owner responsibility. The HOA will no longer be spraying the pea gravel areas for weeds. There is a pile of extra pea gravel outside of the old maintenance garage for homeowners to take from. Once it is gone it is gone, so grab some if you need it! Remember to be courteous of the lawn crew and remember that the only reason you should be approaching them is to thank them for their hard work! If you have any concerns or complaints, please relay those to the office staff.

SUMMER CELEBRATION: Sunday, July 24 from 5:00-?, there will be a "Summer Celebration" for Sherwood Green residents and guests. We'll gather at the pool and playground area to have a good time getting to know our neighbors. "Joyce and Friends" will be providing background music to add to the festivities. Bring your own drinks and snacks to share. Don't forget a lawn chair too!

MANAGEMENT: Tempo Properties gave notice of management contract termination last week. Tempo's final day will be August 23rd, 2022. We want to thank the dozens and dozens of people who have been very kind to us for the 2.5 years we have managed you all. POOL NEWS: The Sherwood Green pool is now open for the season! If you have not yet activated your pool key, you can do so by visiting the office M-F 9:00am – 1:00pm (please bring your pool key with you) or email us the 1st 6 digits on the BACK of your key card. If you've lost your pool key, or if you are new to the neighborhood, you will need to purchase a pool key from the office for \$25.00. Pool keys will NOT be activated if there are delinquent charges or fees on the unit's account. Similarly, a pool key may be deactivated if an account becomes delinquent or if pool rules are broken. The pool rules are as follows: The pool hours are 7:00am - 9:00pm - visiting the pool outside of these hours is prohibited. Homeowner/tenant must be present when guests are using the pool. No more than 4 quests are allowed per unit. Children using the pool must always be accompanied by an adult. There is NO drinking or smoking allowed at the pool. Rafts are NOT permitted. Small floaties/pool noodles are permissible. All posted rules must be followed (e.g., no running, no diving). DO NOT stand on/hang from/put unnecessary weight on the rope or allow your children to do so! There is NO lifeguard on duty – swim at your own risk. If there is an emergency, please call 911 and then immediately notify Tempo Properties. Clean up any trash/personal belongings before vacating the pool area. Please take your trash with you when you leave the pool. Violation of the pool rules will result in the loss of pool privileges. If you witness violation of the pool rules, alert the office immediately. When reporting an incident, you must know the offender's name and/or address for office staff to follow up. Please refer to the pool & tennis court rules, regulations, and contract on the Sherwood Green website for further clarification of the pool rules.

TENNIS/PICKLEBALL/BASKETBALL COURTS: Must be a homeowner/tenant to use the courts. A key will be issued upon owner request by management at a cost of \$15.00/key. If you lost your key or if you are a new resident, you will need to purchase a new key. Guests (up to 4) must be accompanied by an owner/tenant. No skateboarding, roller skating, drinking, etc. will be allowed on the courts. They are for sports only. Violators will face loss of court privileges.

<u>PARKING:</u> The turnaround spots on the private streets are *not* to be used for overflow parking. When parking on public streets you should park with the flow of traffic – not against. As always, please refrain from parking on ANY sidewalks/grassy areas/*private roadways*. Refer to the governing documents for further parking rules and regulations. *Warning tickets will be issued to those found in violation and a second offense will result in a \$25 fine. Upon the third offense, towing will occur at the owner's expense.*

<u>SAFETY:</u> Please be sure to keep your car doors locked when left unattended outside. In addition to making sure your vehicle is locked when not in use, I urge you not to leave valuables inside the vehicle (wallet, purse, etc.). You should do your best to not leave your garage door open as this is a prime target. If you see suspicious activity, please contact the **Bloomington Police Department** by using the non-emergency line: **(812)** 339-4477. If you are experiencing a true emergency, always dial 911.

<u>STICKS/LIMBS</u>: Please DO NOT place limbs or sticks on ANY HARD ASPHALT SURFACES. During a rain, these will clog storm drains and damage others' belongings. Let us be courteous of the membership and do what we can to keep everyone safe and dry. If you feel you must tend to small sticks in the Common Area, please leave them IN THE GRASS by the edge of the sidewalk or roadway.

<u>PETS:</u> Please remember that ALL pets are required to be leashed and supervised while outside! Tethers that extend beyond the threshold of your patio are prohibited by the Sherwood Green HOA. Per the governing documents of the HOA, it is reiterated: *Pets are not permitted to freely roam the Common Areas in Sherwood Green. This is considered a public nuisance and are subject to apprehension by Bloomington Animal Care & Control as well as fines issued by the Sherwood Green HOA. Accordingly, all animal recovery efforts and expenses are the sole responsibility of the handler. Warnings will be issued for first-time offenders. A \$25 fine will be charged to your account for each occurrence after the warning.*

APPROACHING CONTRACTORS AROUND THE GREEN: This message is posted in each of our Green Sheets, but we continue to have issues. If an Association contractor is doing work on your building or unit and there is an issue, do not approach the contractor - call the office. Furthermore, please do not directly call HOA vendors unless you are hiring them for a service (i.e., flowerbed care, interior maintenance, etc.). Any exterior work resulting from such acts could result in your account being billed for services performed without HOA Board approval.

EXTERIOR CHANGES: If you are making exterior changes such as installing new windows, garage door, patio gate, installing a satellite dish, flagpole, etc., the change must be approved by the Board of Directors. Exterior alteration forms are available in the office or online at www.sherwoodgreenbloomington.com

GARBAGE & RECYCLING: Garbage/recycling bins are to be stored in your garage or on your patio near the door. This is a rule across the Green and it is not a new rule. Also, animal waste belongs in YOUR OWN garbage bin. Passers-by often leave their waste in the nearest receptacle rather than disposing of it at their home. And even though some people do not even have animals, their trash receptacles smell of animal waste. Let us try to be respectful of our neighbors and only use our own trash receptacles. Warning tickets will be issued to those found in violation and further offense will result in a \$25 fine.

<u>GREEN BOOKS/WEBSITE</u>: The Sherwood Green governing documents, also called *The Green Book*, with the Rules and Regulations, CCR's, By-Laws, etc. are always available in the office for a charge of \$20 (to cover materials). Reach out to the Office Manager to obtain a copy or refer to the SG HOA website! Our website, <u>www.sherwoodgreenbloomington.com</u> is a great resource for recent Minutes from HOA meetings, copies of governing documents, alteration request forms and more! Please keep in mind that the Association has the right to issue a fine of \$25 for non-compliance with the governing documents of Sherwood Green Homeowners' Association, Inc.
