#### **Old Business:**

#### **New Business:**

- 1) Updating Rules and Regulations: The Rules and Regulations have been updated to include the following changes:
  - Made a new section "Common & Limited Common Area" that was extracted from the existing section "Work Order and Exterior Alterations".
  - Updated "Pea Gravel Areas" to include note about plantings and the approved shrub list, type of mulch that is allowed, trees and ornamental trees are not permitted and the area is not to be used for storage.

- Made a new section "Security Cameras on Units". This section covers exterior alteration requests to install a camera.
- Updated the "Trash" section to clarify the placement of trash and recycling receptacles.
- Updated the "Pets" section to include rule about pet tethers in the Common Area.

### **Resident Comments Summary:**

- 946 Commons the owner asked about the plan for the hill in front of her unit. The roots will have to be ground out more and the area will be seeded and strawed later this year
- 3113 Eden the owner sent in a work order because she has a leak around her window(s) and believed it was from the siding that was installed in 2023. The Board had the original siding contractor and a second siding and window contractor look at the windows. Both contractors said the replacement windows were not properly installed, they were set too far back into the opening and the leak was not from the siding. The window openings in Sherwood Green are not a standard size and either have to be custom ordered or properly trimmed out to fit the opening. The owner asked who she should call to repair the windows and a Board member suggested the original installer.
